7. Unfinished Business: No unfinished business



Parliamentarian Malamut informed attendees that there would be a discussion, debate and vote on the proposed bylaws package. The proposal would require a 2/3 vote of present voting members to adopt. He also noted that proposed amendments would not be accepted.

It was moved (Debra Carlton-Elk Grove SL) and seconded (Robert Rodriguez – Porterville YSL) that the proposed revisions to the Constitution, Bylaws and the General Procedures and Specific Rules be adopted, replacing the Constitution and Bylaws with a combined document to be titled Bylaws and replacing the General Procedures and Specific Rules with a Policies and Operations Manual as previously noticed with the call of this meeting, and with the modification to conform the name to the legal name of California Youth Soccer Association, Inc, and with all of the grammatical and spelling errors to be corrected and all of the numbering and lettering conformity to be arranged as necessary by the Secretary.

Parliamentarian Malamut noted that the proposal would be open to debate and would alternate between pros and cons of the proposal. Attendees should send debate requests to Parliamentarian James.

Parliamentarian Malamut called for an immediate vote and noted that the initial vote would be by voice, and if there were any questions a roll call vote would be held.
