Background Check

STEP 1

Log in to your GotSport account at system.gotsport.com

STEP 2

Depending on your the role you have with your club, the user requirements will consist of either Intro to Safety, SafeSport, LiveScan, and Background Check, or all four. These user requirements will be located on your account "Dashboard." Click the "Details" for the respective requirement to continue.

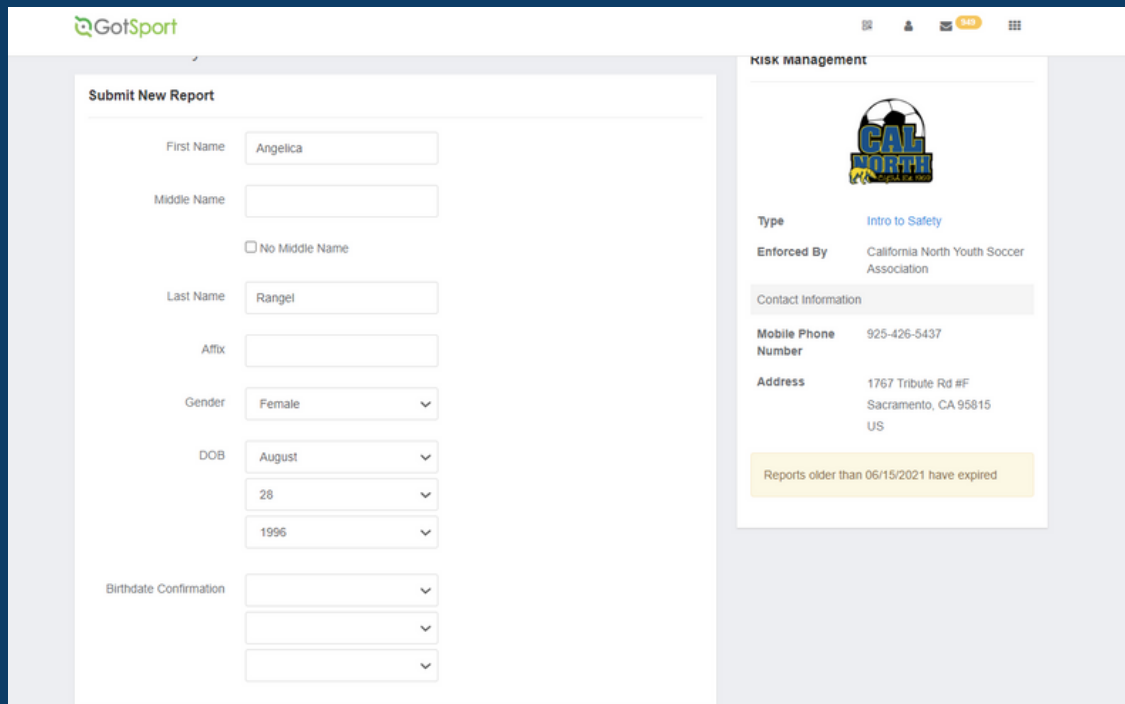

*In order to be rostered to a CalNorth team you must complete a JDP background check questionnaire. The JDP background check performs national criminal checks on participating adults. The national data sources include but are not limited to: Department of Corrections, sex offender registries, criminal records, U.S. Youth Soccer's Disciplinary Action and Risk Management Report (DARM), and U.S. Center for SafeSport's Centralized Disciplinary Database. The background check questionnaire takes approximately 15 minutes to complete. Please note that this is not a Credit Check. JDP is a consumer reporting agency governed by the Fair Credit Reporting Act and is required to provide you information about the Fair Credit Reporting Act during the background screen. JDP will not be running any type of Credit Check/Report on you. Background check results are automatically marked as approved when a report is received that contains no criminal information.

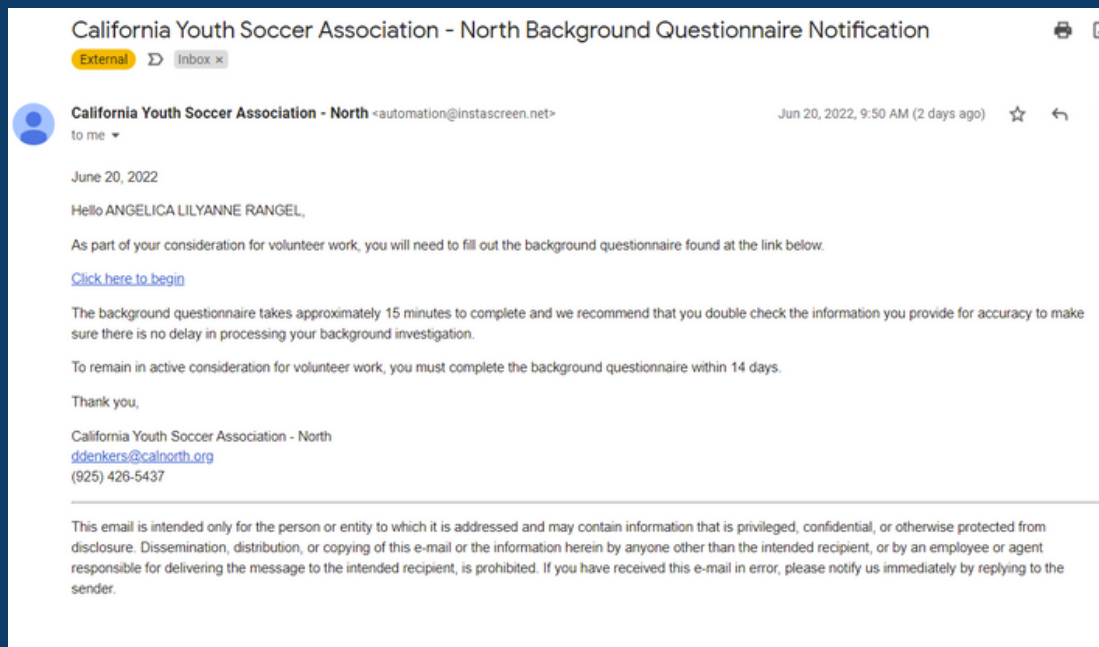
