STEP 1

Log in to your GotSport account at <u>system.gotsport.com</u>

STEP 2

Depending on your the role you have with your club, the user requirements will consist of either Intro to Safety, SafeSport, LiveScan, and Background Check, or all four. These user requirements will be located on your account "Dashboard." Click the "Details" for the respective requirment to continue.
